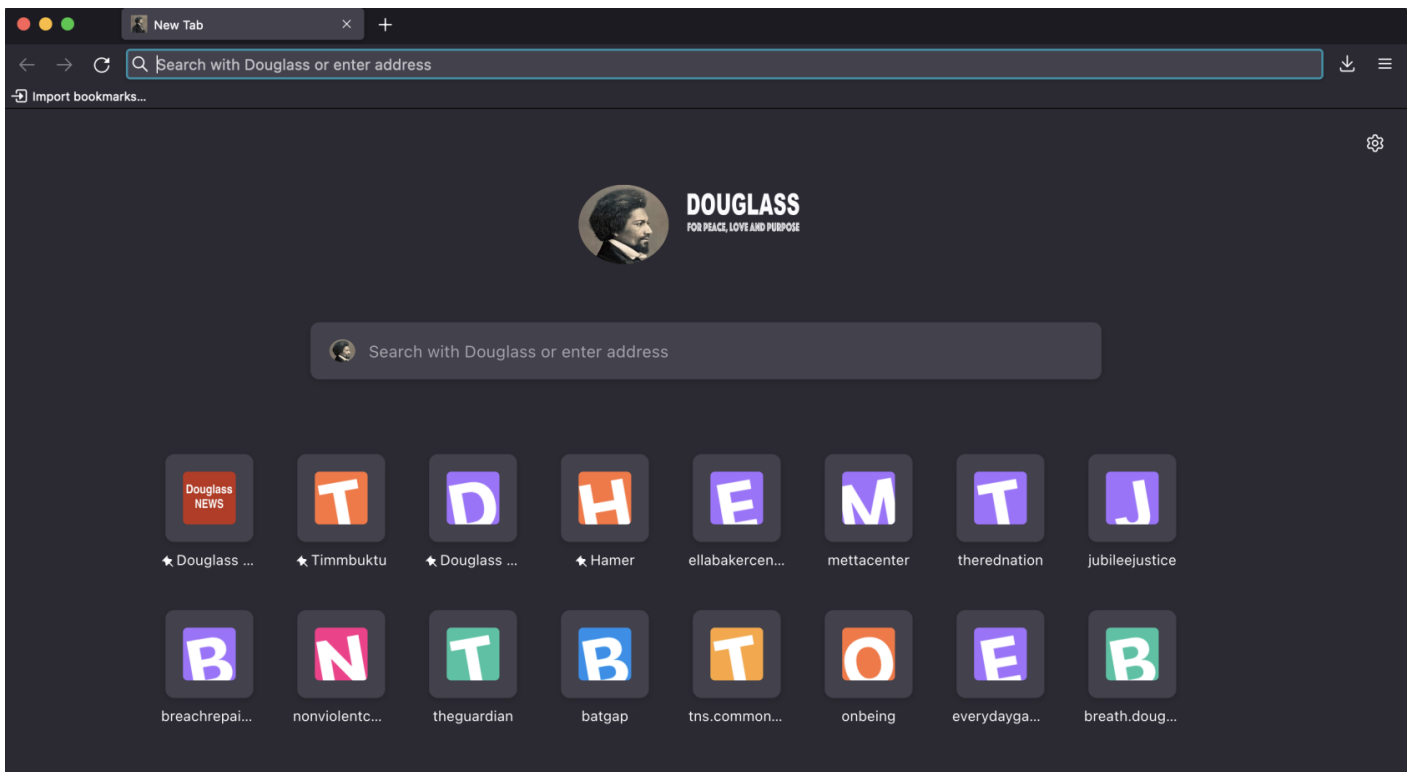

# Privacy Policy: Douglass Browser

The Douglass Browser is **privacy-focused**. It offers tracking protection and removes many features that decrease users' privacy, such as Pocket, Telemetry, data collection and startup profiling. It is also able to erase all online data on your system without the use of add-ons.

We strive to collect only the absolute minimum to provide you with a useable web experience. We try to avoid any personal data where we can and keep data collection to the minimum.

We believe you should always know what data we collect from you and how we use it, and that you should have meaningful control over both. We want to empower you to make the best decisions about the information that you share with us.

The Douglass Browser does not collect telemetry about your installation - any telemetry modules are disabled when the browser is built. What you do in your browser is only known by you.

The Douglass Browser uses the privacy protecting Douglass Search Engine. With The Douglass Search Engine there is No user tracking, No user profiling, AND Cookies are not used by default.

## Improve security for users everywhere

Desktop versions of The Douglass Browser check for updates by persistently connecting to Douglass' update servers. Your Douglass Browser version, language, specific search configurations and device operating system are used to apply the correct updates.

The Desktop version of the Douglass Browser periodically connects to external services to protect you and others from malicious add-ons. Your Douglass Browser version and language, device operating system, and list of installed add-ons are needed to apply and update the add-ons blocklist.

When you visit a secure website (usually identified with a URL starting with "HTTPS"), The Douglass Browser validates the website's certificate. This may involve The Douglass Browser sending certain information about the website to the Certificate Authority identified by that website. Opting out increases the risk of your private information being intercepted.

The Douglass Browser always asks before determining and sharing your location with a requesting website (for example, if a map website needs your location to provide directions). To determine

location, The Douglass Browser will use your operating system's geolocation features.

If you allow a website to send you notifications, The Douglass Browser connects with a third party service and uses your IP address to relay the message. The Douglass Browser nor the third party service can access the content of messages.

## Douglass Community Privacy Policy

This Privacy Policy describes how The Douglass Community collects, uses, shares, and safeguards personal information.

This Privacy Policy also tells you about your rights and choices with respect to your personal information, and how you can reach us to get answers to your questions. Nothing in this policy shall be construed to mean that any particular law applies to the data or processing described herein, including without limitation the California Consumer Privacy Act and the General Data Protection Regulation.

## We do not sell your data

We do not sell your personal data. Our business model is to provide you with a free edition and we charge you for extra services or features, according to the plan you choose. What you process within Rosa is yours and stays your.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.

## Types of Data Collected

### **Personal Data**

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:



- Email address
- First name and last name
- Cookies and Usage Data
- We may use your Personal Data to contact you with newsletters, marketing or promotional materials, and other information that may be of interest to you, if you have provided consent to this processing or if we can base this processing on a legitimate interest that is not overridden by your fundamental rights. You may in the future withdraw that consent or object to receiving any, or all, of these communications from us by following the unsubscribe link or instructions provided in any email we send or by contacting us

## **Account Data**

Rosa requires that you register for a personalized account. Account data may include in addition your account name, authentication information, registration date, contact information, payment information, and any other information associated with your account.

## **Usage Data**

We may also collect information that your browser sends whenever you visit our Service or when you access the Service, incl. by or through a mobile device (“Usage Data”).

This Usage Data may include information such as your computer’s Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When you access the Service by or through a mobile device, this Usage Data may include information such as the type of mobile device you use, the IP address of your mobile device, your mobile operating system, the app version, the type of mobile Internet browser you use, unique device identifiers and other diagnostic data.

As a byproduct of the usage data within a Rosa Administrators may choose to share aggregated and therefore anonymous, non-personal data with us to help us learn more about how our product is being used.

We may use and store information about your location if you give us permission to do so (“Location Data”). We use this data to provide features of our Service (only to allow you to share your location to another user via Rosa, if it was enabled by the administrator).

You can enable or disable location services when you use our Service at any time, through your device settings.

## **Content you provide**

When you use our Services you may provide content into that service (e.g. upload file, send a message).

## **Tracking & Cookies Data**

We use cookies and similar tracking technologies to track the activity on our Service and hold certain information.

We regularly monitor aggregated activity data on our infrastructure, but it is not tracking of individual users in the sense of this paragraph, which only occurs when we have a legitimate interest to do so (e.g. for security and compliance purposes). We do perform regular tracking on Rosa.

Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

Examples of Cookies we use:

- Session Cookies. We use Session Cookies to operate our Service.
- Preference Cookies. We use Preference Cookies to remember your preferences and various settings.
- Security Cookies. We use Security Cookies for security purposes.

# How do we use information?

We collect and use your personal data to the extent necessary to carry out our operations and provide our services as well as to comply with any regulatory obligations in our activities.

These purposes are defined in more detail below:

- To provide and maintain our Service
- To notify you about changes to our Service
- To allow you to participate in interactive features of our Service when you choose to do so
- To provide customer support
- To gather analysis or valuable information so that we can improve our Service
- To monitor the usage of our Service

# Legal Basis for Processing Personal Data

## **To comply with legal and regulatory obligations**

We collect and use your personal data to comply various legal and regulatory obligations, such as:

- Anti-money laundering regulations and counter-financing of terrorism regulations, including Know Your Customer (KYC) obligations.
- Regulations relating to international financial sanctions and embargoes.

## **To fulfil our legitimate interest**

We also use your personal data to fulfill our legitimate interests, which include the following:

- Provision and delivery of our products and services.
- Marketing and customer communication and development of our customer relationships.
- Development of our products and services.
- Security and safety of our IT and facilities.

## **Based on your consent**

If processing of certain personal data requires your consent (e.g. cookies), we will inform you of this including details of the specific processing activity and request your consent to such processing. You may request to revoke your consent at any time.

# Retention of Data

Douglass P.B.C will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

Douglass P.B.C will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer time periods.

# Transfer of Data

Your information, including Personal Data, may be transferred to — and maintained on — computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from your jurisdiction.

If you are located outside United States and choose to provide information to us, please note that we transfer the data, including Personal Data, to the United States or other jurisdictions deemed not not have an adequate level of data protection deemed by the competent authorities of your residence.

Douglass P.B.C. will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

# Disclosure of Data

## Business Transaction

If Douglass P.B.C. is involved in a merger, acquisition or asset sale, your Personal Data may be transferred. We will provide notice before your Personal Data is transferred and becomes subject to a different Privacy Policy.

## Disclosure for Law Enforcement

Under certain circumstances, Douglass P.B.C. may be required to disclose your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency).

## Legal Requirements

Douglass P.B.C. may disclose your Personal Data in the good faith belief that such action is necessary to:

- To comply with a legal obligation
- To protect and defend the rights or property of Douglass P.B.C.

## How Hamer Works

### Members & Groups

Members of the Hamer Community Network can be assigned to one or multiple member groups. Member groups are used to manage group level permissions as for example the permission to create spaces or access certain areas of the Hamer network as the directory. You can either automatically assign members users to a certain group or let them choose from a set of user groups in the registration process.

### Spaces

The Hamer Community Network is separated into multiple spaces. A space serves as an independent area within The Hamer Commun Network with it's own set of members. Most content created within The Hamer Community Network as posts, events or wiki pages are linked to a specific space. Space's can be created for projects, or any kind of community topic.

### Streams



In Hamer Community Network, streams are used to display and filter recently created contents and activities. The following types of streams are available in the Hamer Community Network.

- **Space stream:** This space level wall stream includes contents related to a specific space
- **Profile stream:** This profile level wall stream includes contents related to a certain user and by default also includes content created by a user within spaces
- **Dashboard stream:** A network wide wall stream includes contents of spaces and profiles a user is following
- **Activity stream:** Sidebar stream which lists activities within the whole network or on space level

## Activities

Beside the wall streams, which display actual content entries as posts or calendar events, the activity stream lists various information about recent activities within The Hamer Community network or a single space. An activity for example could be a new member joining a space or a user liking a post. Activities are also part of the summary mail sent out to users to keep them up-to-date with recent network activities.

## Posts

In The Hamer Community Network, posts are the simplest form of content. Members can create posts directly within the start page of a space or on their member profile wall. Hamer provides a WYSIWYG editor for most text based contents in order to add simple formatting as headlines or bold text as well as oEmbed or file uploads.

## Notifications

Notifications are sent out to member to inform them about user related events as new comments or likes on a posts. In contrast to activities, notifications are always directed to a single member and not the whole network or a space.

## Dashboard

By default, the dashboard is the starting point for all of Hamer Community Network members. The dashboard provides a quick overview of all recent contents and activities of all spaces and profiles a user is following and may contains additional sidebar elements as for example a task or calendar overview snippet.

## Directory

The directory serves as an overview of the whole network and provides a list of groups, members, spaces as well as a wall stream with all public user profile posts.

# Topics

Topics can be used to classify and filter contents within a stream by attaching one or multiple topic labels to a content entry.

## **No promotional posting, no spam**

The Hamer Community is not a site for self-promotion, SEO, PR, marketing, or advertising. There are extremely limited circumstances under which it is acceptable to link to your own work, your company's work, or any work you've been hired to promote. Posting outside of these circumstances is grounds for an immediate ban. If you're joining specifically for any of these purposes, stop now and save us both some time.

## **Speak for yourself, not others**

Speak from your own experience and perspective. Say things you genuinely mean (rather than playing devil's advocate, trolling, or saying bad things ironically). Avoid downplaying a problem just because it is not a problem for you. Avoid speaking on behalf of other people and discussing their experience like an academic topic; invite them to speak for themselves instead!

## **Be considerate and respectful**

The Hamer Community is a space for conversations, not a contest; add your own informed perspective and nuance instead of shutting others down. Extend the benefit of the doubt in conversations and earn the benefit of the doubt that others are extending to you. Listen if someone says they're upset and be willing to apologize and step back.

## **Be sensitive to context**

Read a post before commenting. Engage with what people are really saying. Respond appropriately to people's mood and investment in a topic. Refrain from making light jokes in a serious discussion. Avoid analogies or hypotheticals in charged discussions; these often involve ignoring or distorting the actual context of the conversation.

## **Be aware of your privilege**

Recognize your own positioning. Be aware of how much space you are occupying in a discussion and avoid exclusionary or insensitive statements that can harm or alienate other people. In a

conversation where you're in a privileged group, take active care to avoid making it about yourself or diverting the topic (intentionally or accidentally) particularly where systemic power is involved (race, class, gender, etc). Remember that each person has different stakes and direct experience in a conversation.

## Be mindful of micro-aggressions

Use people's correct name, gender, and pronouns. Be respectful. Do not exoticize or joke about another culture's touchstones — things like names, food, language, religious concepts. Avoid stereotypes and outdated terms. Believe people about their own experiences.

## Accept feedback gracefully

Be willing to listen and apologize if someone says you've said something hurtful. If someone criticizes your ideas or statements, or points out harmful impacts, it's not a personal attack. Remember that you can do harm without intending to. Sometimes it is necessary to take a step back and let the conversation move on.

# Hamer Content Policy

Hamer is a community where anyone that is aligned with Peace, Love, and Purpose can participate. We encourage open conversations between members and value the different contributions that make the Hamer Community positive and dynamic.

We have a set of Community Guidelines that we expect all members to follow and staff who provide round-the-clock moderation and support.

In order to keep the discussions in the Hamer Community healthy, we have outlined the policy below to serve as a guide of the types of content and behavior that will be considered inappropriate and may lead to removal of content, warnings or having your account banned.

## Inappropriate Content

The following types of content or behavior will not be tolerated:

**Hateful content:** Posting racial slurs, deliberately misgendering/misnaming, or other racist, misogynist, homophobic, transphobic, or otherwise hateful speech. This includes making hateful statements ironically or sarcastically.

**Name calling:** Any kind of name calling and/or cursing directed at others in a conversation. (Pointing out that a statement is inappropriate or otherwise problematic is not name-calling.) In general, cursing is fine on the site, but cursing at someone else is not okay.

**Trolling:** Systematically posting content solely intended to upset or provoke an angry response.

**Doxxing:** Posting someone else's personal information without consent. If someone hasn't explicitly and intentionally brought their personal information into a public discussion, don't make that decision for them.

**Hacking Impersonation Misrepresentation:** Compromising or accessing another person's account or pretending to be somebody else.

**Stalking/harassment:** Any unwanted and obsessive attention or otherwise creepy behavior making other members or staff. This includes contacting someone after they have said they do not want to be contacted by you.

**Discrimination:** Any type of discrimination or offensive content based on (but not limited to) age, appearance, body shape, ethnicity, disability, gender identity, race, religion, sexual orientation. This includes demanding members to provide information about their identity within a conversation.

**Spamming:** Posting or advertising unsolicited commercial/promotional content.

**Violence:** It can be okay to talk in strongly critical terms about people's words but don't cross the line into any threats of violence or wishing violence on other people.

The BCL is a Non Violent Software, Hardware and Product License that has been created for: Peace, Love and Purpose.

The BCL is based on an understanding and recognition of: Martin Luther King's "[Beloved Community](#)", and a Social Activism that pursues a future of Peace, Love and Purpose for all.

## Recognition and Possibilities

- When possible Software, Hardware and Products issued under the BCL will be used to improve the lives of the Multitudes of the World that are oppressed and in struggle.
- When possible Software, Hardware and Products issued under the BCL will be used to foster the development of equitable and inclusive political and economic spaces.
- When possible Software, Hardware and Products issued under the BCL will be used to enable the enfranchisement of the incarcerated into the daily activities of our communities.
- By using Software, Hardware and Products Issued under the BCL you recognize the Preciousness of all with special attention to the hungry, the homeless and the oppressed.
- By using Software, Hardware and Products Issued under the BCL you recognize that reparations and atonement are a part of a needed community healing process.
- By using Software, Hardware and Products issued under the BCL you recognize the Preciousness of the earth.
- By using Software, Hardware and Products Issued under the BCL you recognize the humanity of the incarcerated.
- By using Software, Hardware and Products Issued under the BCL you recognize that Housing, Food, Health Care and Education are Human Rights that should be provide to all.

## Usage Restrictions

- Software, Hardware and Products issued under the BCL cannot be used for any violent purpose.
- Software or Hardware issued under the BCL License cannot be used for surveillance of any kind.
- Software, Hardware and Products issued under the BCL cannot be used for War.
- Software, Hardware and Products issued under the BCL cannot be used to support Military activities.
- Software, Hardware and Products issued under the BCL cannot be used to inflict violence upon the Earth.

- Software or Hardware issued under the BCL License cannot be be used by institutions of incarceration.
- Software, Hardware and Products issued under the BCL cannot be used to support the activities of Institutions of Incarceration.
- The Douglass Community does not support judicial and legal systems that enforce corporal punishment, or retributive justice.

As a first measure disputes concerning the terms of the BCL will be adjudicated through a community driven Non-violent communication process.

# Timbuktu

Timbuktu is the Douglass communities marketplace that is aligned with the [Beloved Community Pledge](#) and the [Beloved Community License](#).



## Welcome to Timbuktu!

Timbuktu is the Douglass Communities marketplace that is aligned with the Beloved Community Pledge and Beloved Community License. Timbuktu is named after the Western African trade capital.

Through the Timbuktu market, users can sell and purchase a wide variety of specialty goods and merchandise. The primary area of focus is green-friendly and ethically aware merchandise, as well as healthy & natural edibles and body care products.

A large focus point for Timbuktu is fostering a sense of togetherness and community co-ownership. This is intended to be a sharp contrast to existing online marketplace models such as Amazon, that

tend to enable price gauging from sellers, and remain cold and impersonal with no real connection to community.

Unlike Amazon, At Timbuktu there are no high monthly fees for sellers, nor fifteen percent transaction fees. Users moving from Amazon to the Timbuktu platform will notice a drastic difference in terms of both what they can expect from Timbuktu, and in what Timbuktu expects from it's users. Just as prospective users have higher standards for Timbuktu, Timbuktu holds it's members to the Douglass Community standards.

At Timbuktu sellers pay five dollars per month with a ten percent transaction fee. Because "We are all in this together" Upon launch, part of Timbuktu's revenue will be shared with FreedomTrain Community Asset Fund. Hamer members are also poised to benefit from FreedomTrain related loyalty programs. Since Timbuktu cares more about ethical behavior from both users and itself, price gauging, item misrepresentation, buyer/seller canceling and the like will be much more closely watched and moderated.

The Douglass Community Asset Fund will facilitate projects that are supported by the Community and that aligned with the Beloved Community Pledge and Beloved Community License. These projects could range from saving the tropical rain-forests, to disaster relief efforts, or developing green-friendly technology. Douglass approved Freedom Train initiatives might also include helping out impoverished neighborhoods and towns, supporting local food drives, or helping out a particular charity. The sky is the limit here, but really it's all up to the community, because we're all in this together.

Concerned users need not worry about the asset pool being used to fund some unnamed billionaire's fourth private jet, though. Timbuktu doesn't do that sort of thing.

Douglass Community Economics recognizes, that people are interdependent with one another and with Nature, so each person's well-being is measured by how well everyone and the environment are functioning with the goal of minimizing suffering for people and the planet. A communities well-being is measured by the aggregation of the well-being of all residents and the health of the ecosystem.

Douglass Community Economics strives for a holistic optimal outcome and evaluates a policy by how much it minimizes suffering. By reducing the suffering of people living impoverished and bleak lives, we improve the well-being of everyone.

Douglass Community Economics takes into consideration the protection of the environment, the state of the human spirit, and the quality of life of all people.

Timbuktu strives to adhere to these principles at every turn, and makes every effort to enable a better community embodying these values. Leading by example, Timbuktu's more conscientious stance on both seller and buyer behavior lets it promote a system with better user satisfaction. The hard line on ethics lets it promote better employee treatment and a more attractive prospect for long term career options. A drastic improvement over less savory options such as Amazon, which have been known to have concerning employee working conditions in the past, and a lack of concern with transaction abuses committed through their site.

Members of the Hamer Community will have the ability to propose and vote on Freedom Train Initiatives. Freedom Train Initiatives must be centered in: Mutuality, Good Intention and Peace, Love and Purpose. All approved Freedom Train initiatives will be funded by the Douglass Community Asset Fund. All approved Freedom Train Initiatives will be developed by the Freedom Train's core development team or Freedom Train cooperatives.

A major goal for Timbuktu's quest to better the world around us is to help our users see and feel the results of their contributions. To that end, we encourage member involvement in deciding the direction for what FreedomTrain initiatives will be prioritized with the Community Asset Fund. We also encourage users to check in on the list of ongoing or completed FreedomTrain initiatives. As more and more of these goals are completed with funding provided by Timbuktu, users can look forward to watching strong growth and expansion from Freedom Train.

# Ida



## The ida:// peer to peer protocol

The ida:// peer to peer protocol is named in honor of **Ida B. Wells**



**Ida B. Wells** was an African American teacher, journalist, civil rights pioneer and suffragist. Ida B. Wells was one of the founders of the NAACP. Over the course of a lifetime dedicated to combating prejudice and violence, and the fight for African American equality, Wells arguably became the most famous Black woman in America.

## IDA

The Ida protocol provides decentralized distributed secure file hosting and sharing with dynamic versioning. When files are added to the Ida protocol and shared with anyone in the Douglass community all versions of the files are saved and are accessible to any member of the Douglass community that have been granted permission to access the files.

With Ida and the Douglass Browser you can Build and host decentralized and pages and apps without an internet services provider.

# Decentralized Mirroring

IDA is a decentralized protocol that designed to facilitate the exchange of pieces of a dataset into a network of peers. When a peer acquires it's first piece of data they can choose to become a partial mirror for the dataset. If a peer contacts them and needs a piece of data they have, they can choose to share it. This can happen simultaneously while the peer is still downloading the pieces of data they want from others.

## Ida Features:

- Ida's unique decentralized protocol gives communities the ability too: share, store, and distribute data where and when they want.
- Ida is designed to be the storage layer for fast, scalable, and secure decentralized applications.
- Ida is a decentralized filesystem that is designed to help you share files quickly and safely, directly from your computer.
- You can share entire filesystems with others using a single 32-byte key (i.e. ida `://uwd13d...`)
- With Ida files can be added or modified after a space is created, and peers can "watch" a drive for updates, meaning update notifications are dispatched to readers in realtime.
- By default, users only download the portions of files they need, on demand.
- With Ida you can easily stream media from friends.
- Seeking is fast and easy and there is no buffering.
- With Ida you can seek through a video and it will download only the portions of the video you're viewing, on-demand.
- Ida is designed to help you share files quickly and safely, directly from your computer.
- Ida comes with a secure transport protocol, making it easy to build fast and scalable decentralized applications.
- Dataset/file distribution and sharing happens simultaneously while a peer is still downloading the pieces they want from other peers.
- Ida reduces bandwidth costs as files and data become more popular, downloads are distributed across all available nodes.

- By decentralizing storage and distribution, Ida also increases speeds by downloading from many peers at the same time.
- Ida transfers files using state-of-the-art cryptography. Only users with your unique cryptographic key can access your files. Ida verifies the hashes of content on download, so malicious content cannot be added.
- With Ida user privacy comes first. Services and Applications using the Ida Protocol have encrypted transfer, private data sharing, and content verification built-in.
- Decentralized Network Privacy - Ida guarantees end-to-end encryption of all shared content.
- When Ida sends data to a clusters of peers all of the data is synced within the clusters at the same time. Ida's distributed syncing allows for robust dynamic global archiving.
- Ida uses distributed append-only registers to store dynamic version history.
- Ida mirrors the state of a network peer and all of it's contents.
- Ida automatically maintains and updates built in version history when files are added to the network.
- Progressive Versioning - Ida enabled datasets can be synced in real time to multiple peers in the network.
- The Ida protocols Decentralized Redundancy gives the ability to transfer large amounts of secure data at scale.
- With Progressive Versioning, Ida guarantees that every node hosting Ida content has real time dynamically updated versions.

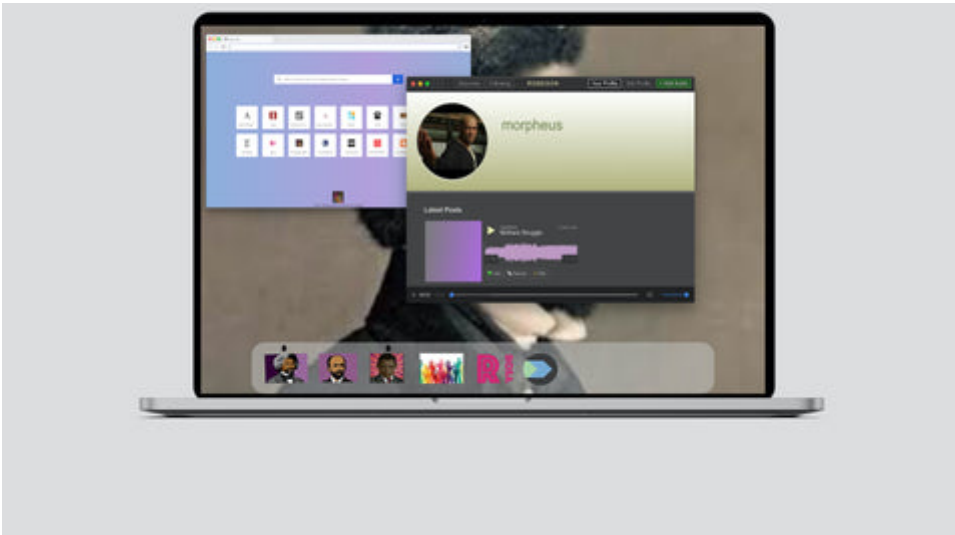

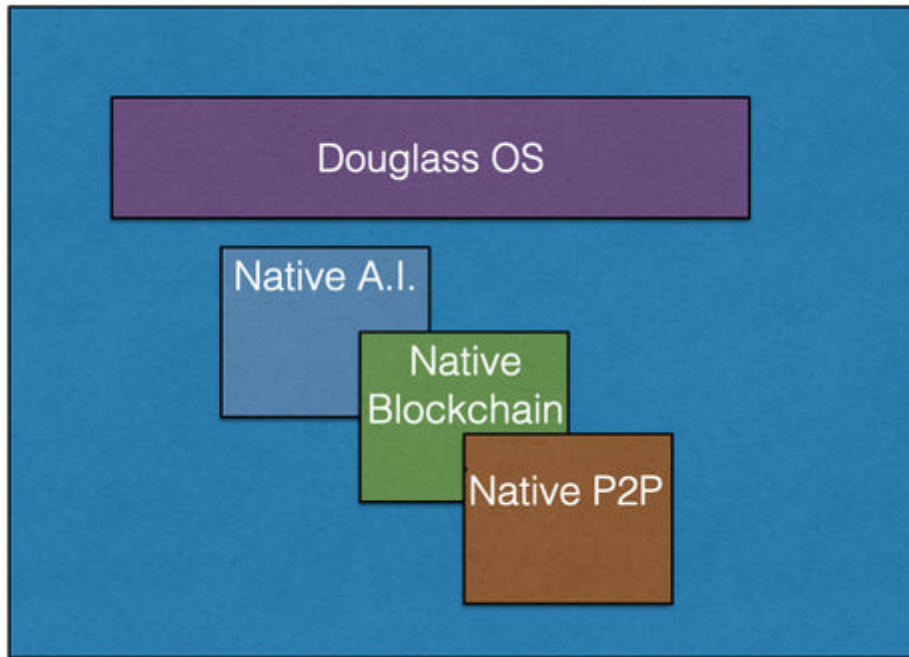

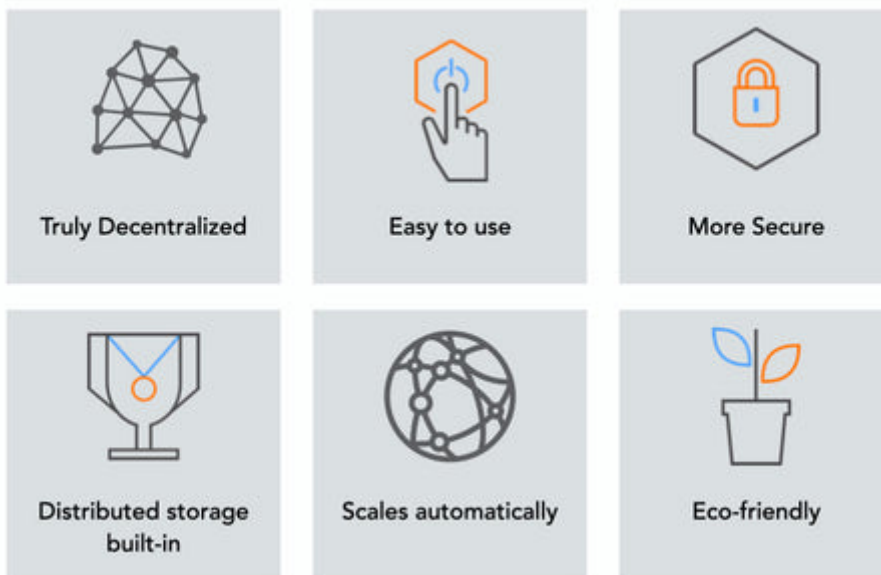

The Douglass Future of Work job board revolutionizes work, breaking it away from antiquated patriarchal structures that devalue community, care and inspiration.

All work will be paid for at an equal rate no matter the geographical location of the job or that of the person(s) doing the work. This means that two people living in different geographic locations will be paid the exact same wage. For example, a person living in San Palo installing solar panels will be paid the exact same wage as a person living in Chicago installing solar panels.

In aggregate, the principal aim of the Douglass Future of Work service is to decouple social progress from environmental breakdown. Even as communities become more empowered and prosperous, the sources of their labour and prosperity shift away from extraction and consumption and towards regeneration and other socially valuable activities. The gradual shifting of economic activity away from material production will also help pave the way to a **post-work** future

All told, it had cost over \$150 million to keep eight humans alive for two years. Avise pointed out, “if we were being charged, the total invoice for all Earths inhabitants, it would come to an astronomical three quintillion dollars for the current generation alone”

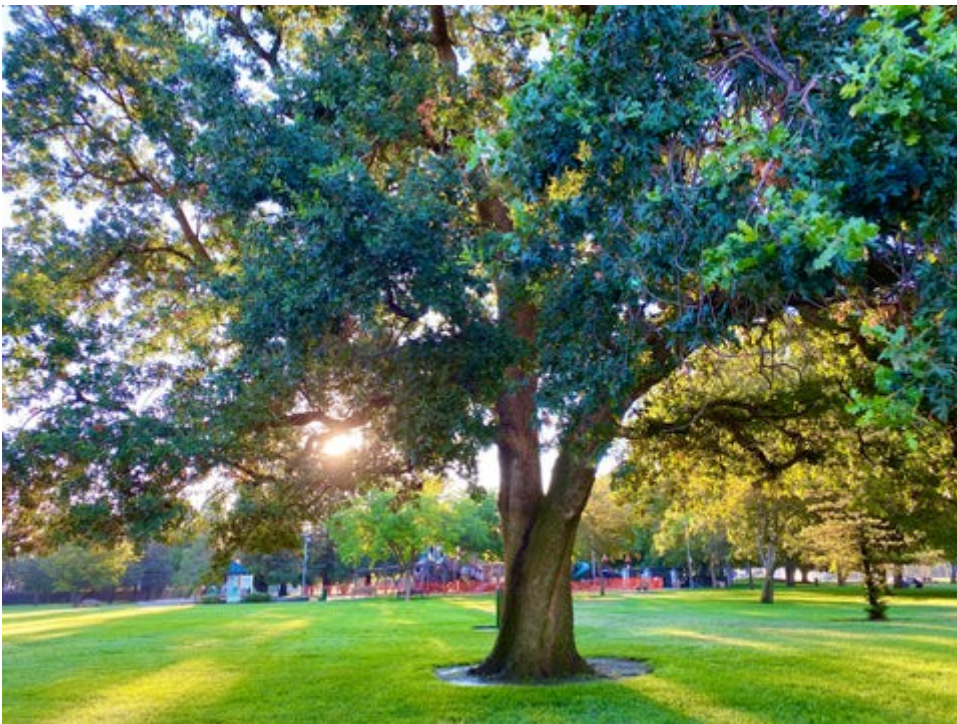

DCT is the name of the **Douglass Community Asset Fund token**. DCT represents the value of all assets owned now and in the future by the Douglass community. Assets owned by the Douglass community can include: Property, Real World Infrastructure, Technology Infrastructure, Community Utilities, Digital Assets, BCL Aligned Tokens, and Revenue Shares in **Douglass Cooperatives**, and Corporate Assets via Cooperative change over.

This grants the highest intrinsic value to Douglass Community Tokens by tying their value to real world assets, rather than based on hedged speculation.

## New Possibilities

DCT will create a compound effect, at once pooling substantive collective investments into a decentralized network which distributes resources to all of sectors, driving the sustainable expansion of community-oriented assets in real world markets, and then distributing truly regenerative returns based on these assets back to Communities.

Imagine the new life-cycle of economic community-sovereignty that emerges from this process, generating new community-sustaining local economies which are no longer tied to endless, unsustainable forms of dangerous debt-leveraged growth; but instead operate in parity with

natural environments, embedded in the participation of millions of people, designed to meet actual local, ecological, social and material needs, and finally creating the foundations for new forms of real prosperity for Communities that can serve to regenerate the planet.

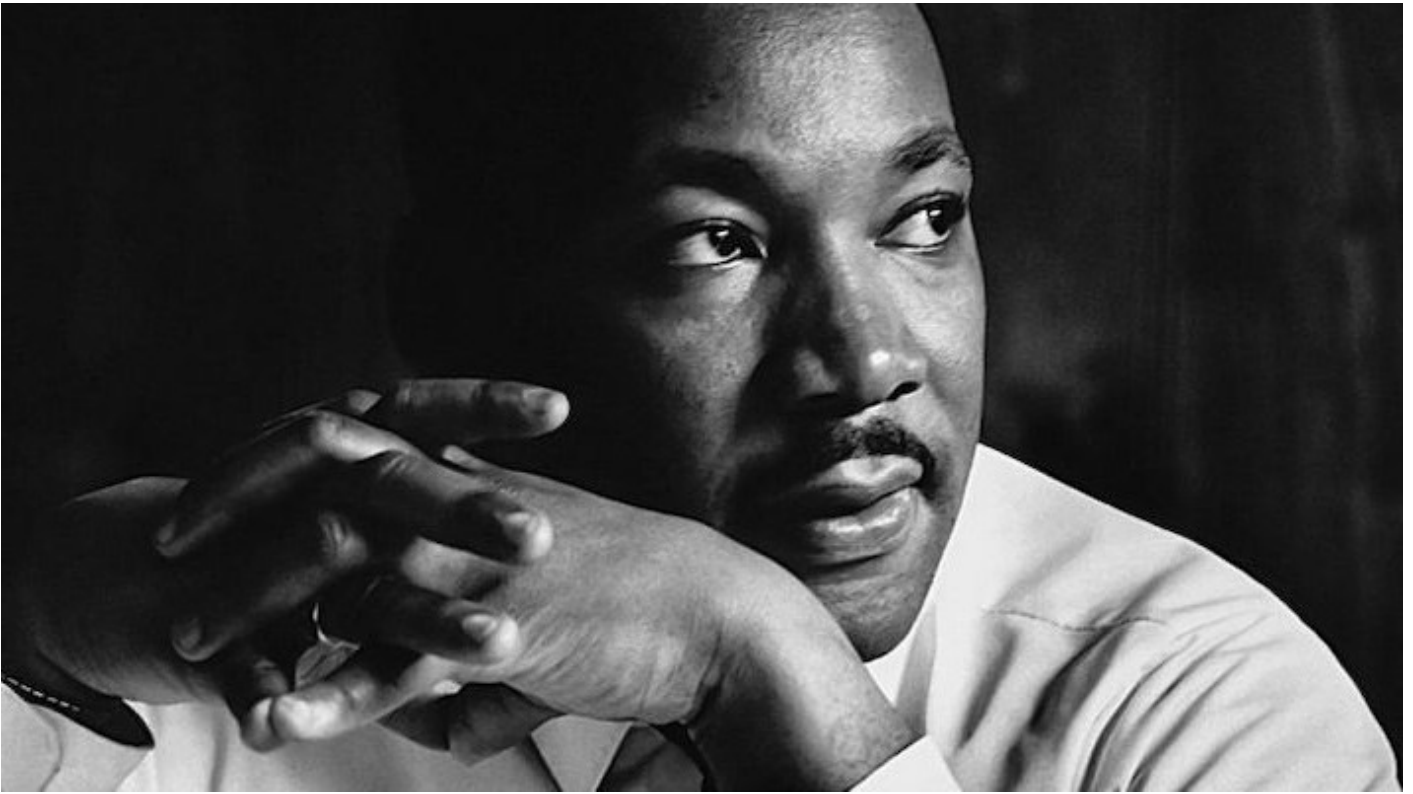

# **FreedomTrain Framework**

FreedomTrain represents a new informational-economic infrastructure for regenerative asset creation and sustainable development.

FreedomTrain seizes upon the singular social, economic and ecological opportunity of our time; the transition from an extractive economic and governance space to a non-extractive Cooperatively owned economic and governance space aligned with Peace, Love and Purpose.

The FreedomTrain Community Empowerment Platform is explicitly designed to facilitate the acquisition, creation and funding of civic and public

goods that are aligned with an understanding of Mutuality and the practice of Peace, Love and Purpose.

Layered on top of the FreedomTrain Community Empowerment Platform is a comprehensive grouping of tools and processes that support Cooperative Communities in the FreedomTrain network as they lead, innovate, organize and communicate .

FreedomTrain represents a potent alternative to both Impact investing and philanthropy, neither of which are capable of creating the social, economic, political and ecological solutions at the scale that is required now.

FreedomTrain's whole systems design approach enhances the ability to see complex scenarios as they arise anywhere in the world, all with local, regional, national and global implications.

FreedomTrain uses this form of design to turn complex ecological and socioeconomic issues into opportunities to regenerate and transform the earth and local communities at scale.

FreedomTrain represents a vehicle for funding the creation and acquisition of digital and real world assets as well as local and global infrastructure opportunities based on actual public needs, where value is derived not from speculation, but from improvements that are designed to regenerate the earth and



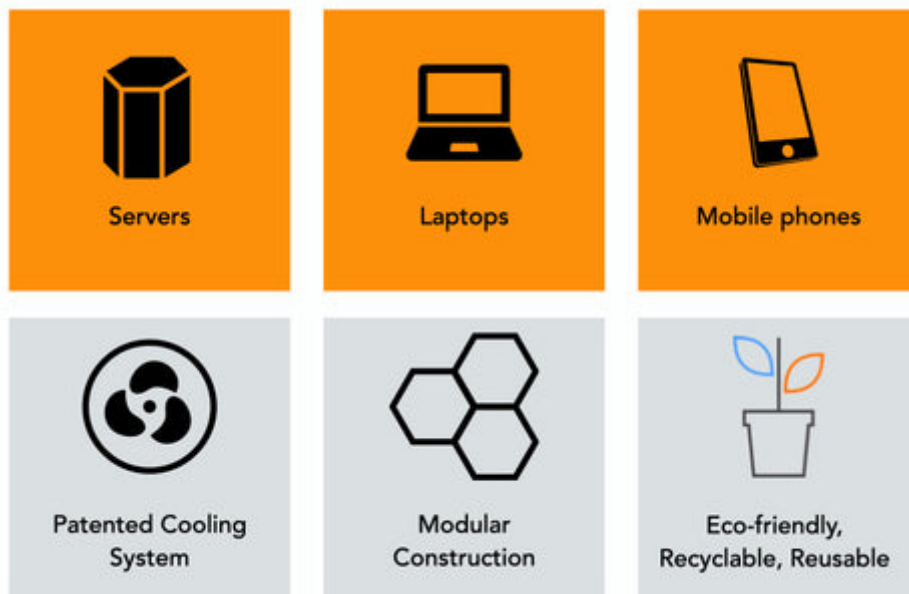
communities at scale from the ground up.

Douglass decentralized servers and laptops will be designed and manufactured in Oakland, California. Also included with the server is a suite of impactful services that are easy to adopt and use. The Douglass Decentralized server will be available in the Fall of 2023



# Douglass Eco Friendly Laptop

Douglass Decentralized Eco Friendly Laptop the first truly environmentally-friendly laptop. We have focused on both what the laptop is made from, and how it is made, in order to reduce energy consumption, encourage re-use and eliminate waste. Douglass Eco Friendly Decentralized Laptops will be available in the Fall of 2023.



# Douglass Edge Computing

## **Empowering Community Value Generation**



With Douglass and ida:// communities replace entrenched monopolies with the ability to provide infinite amounts of storage and compute power that is aligned with the BCL. Global Communities receive revenue and value that will be used to fund the essentials of life as well as Community initiatives. For the first time in technology history Douglass gives communities the ability to replace extractive technology companies with Community based compute and storage that is aligned with Peace, Love and Purpose.

# EDGE Computing at Scale

At Douglass we believe that Computing is entering a major disruption cycle, which will be based on software defined networks, software-defined Compute and software-defined Storage for Community, Personal or BCL aligned organizational use.

Douglass has developed a platform, designed to give BCL aligned communities and organizations the ability to manage their own data without giving this data away to third party SaaS companies.

Data not services should be the first class citizens on the Web. BCL aligned communities and organizations understand this, and Data Governance is at the core of BCL aligned organizations.

On the Web and mobiles we still build applications that hoard data. From this, the idea of data sharing between applications arises.

With Douglass and ida:// we can now build apps in a way that all data belongs not to the app or website owner, but to the community and the user.

## IDA

ida:// is a new decentralized architecture and protocol that is aligned with the BCL and centered in Peace Love and Purpose. ida:// enables decentralized community EDGE computing services that benefits communities as well as BCL aligned companies and organizations.

Douglass and ida:// can be deployed locally, removing dependencies on third party ISP's and Amazon.

## ida:// is the solution for the Decentralized Cloud

Douglass is the first platform that effortlessly enables large-scale EDGE computing. This will open new revenue channels for Global Communities whose value can't even be assessed at present, including emerging IoT and distributed Community owned AI.

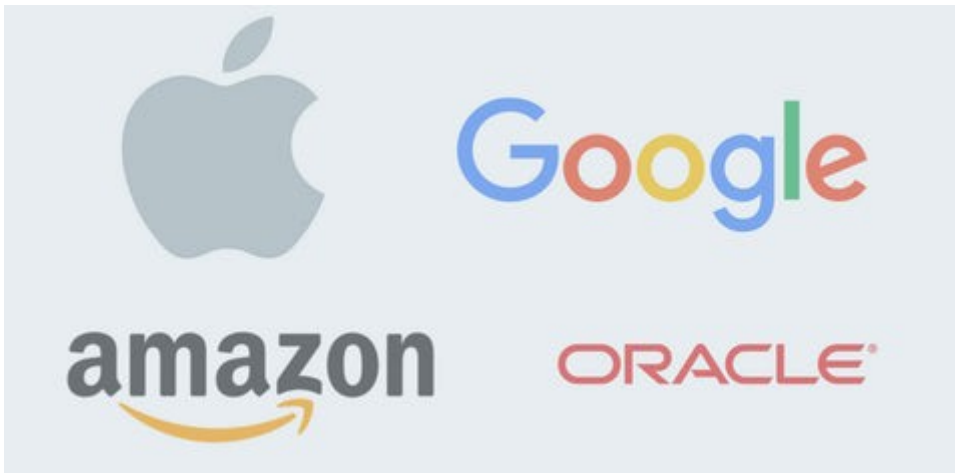

The Douglass OS natively include the ability to deliver content across the decentralized network. This gives consumers access to entertainment content and at the same time it replaces current content distribution architecture with Decentralized storage and distribution.

# What do BCL aligned organizations gain from using [ida://](#) at the high level?

- **Data Sovereignty** - The ability to offer Data Locality / Residency / Sovereignty for private-first offline-first Decentralized applications, with functionality and convenience similar to and surpassing the centralized, Google-style apps.
- **Data Continuum** - The Ability to build apps that work in the [ida://](#) cloud **and** on local PCs and mobiles. Many cloud-native systems only work in the Cloud, which limits their scope of use, and this makes them extremely difficult for developers to debug and test, leading to a huge loss in productivity. AWS is notoriously difficult in that respect.
- **Rethinking AWS from a Decentralized first-principles**

The core idea of the [ida://](#) cloud is to give communities, individuals, and BCL aligned organizations access to Infrastructure and Platform levels of services (IaaS and PaaS), which can only be afforded by large organizations. With Douglass and [ida://](#) Direct infrastructure ownership provides the level of isolation, security and privacy that most closely resembles a decentralized operating systems.
- **Undo and redo** - With [ida://](#) any type of data, document, database, or files can support undo / redo.
- **Data Durability** - [ida://](#) has built-in capabilities for data replication. This can be used to replicate files and databases in community based [ida://](#) clouds. This provides durability of data, with the resilience to hardware failures.
- **Data Integrity, Digital Signatures and Compliance** - [ida://](#) protects all data items from unauthorized modifications and assures that the original data is intact.
- **Recovery** - [ida://](#) uniquely works for both files and databases. [ida://](#) provides point-in-time restore from any past versions of the data state. This simulates both the DynamoDB point-in-time backup / restore and S3 object versioning. This capability can also be used as snapshots, as it allows the ability to checkout the store, tagged at a particular version. This may be used for devops and for development.
- **Offline-first, local-first** -With [ida://](#) All data is available when offline. Messages and media (of any size) are delivered from mobiles to server and back with full reliability, in the presence of intermittent or rare connectivity.



# Douglass Community Edge CDN

ida:// can be used to build Community based Edge CDN's for distributing files to the edge, and distributing load between the replicas. It is static storage friendly. Files and databases can be served from static storage, as in CDNs. Additionally, due to ida's:// BitTorrent-like functionality, it improves CDN capabilities in the following ways:

1. Saves CDN bandwidth costs by bandwidth sharing, turning media watchers into up-loaders
2. Accelerates download as it allows load chunks from multiple peers simultaneously. This is especially important for 4K, VR and 3D printing content.
3. Real-time incremental CDN updates. Many CDNs take significant time to replace old files. And many require the full flush of current files. ida:// can help optimize both with immediate updates and Change Management events.

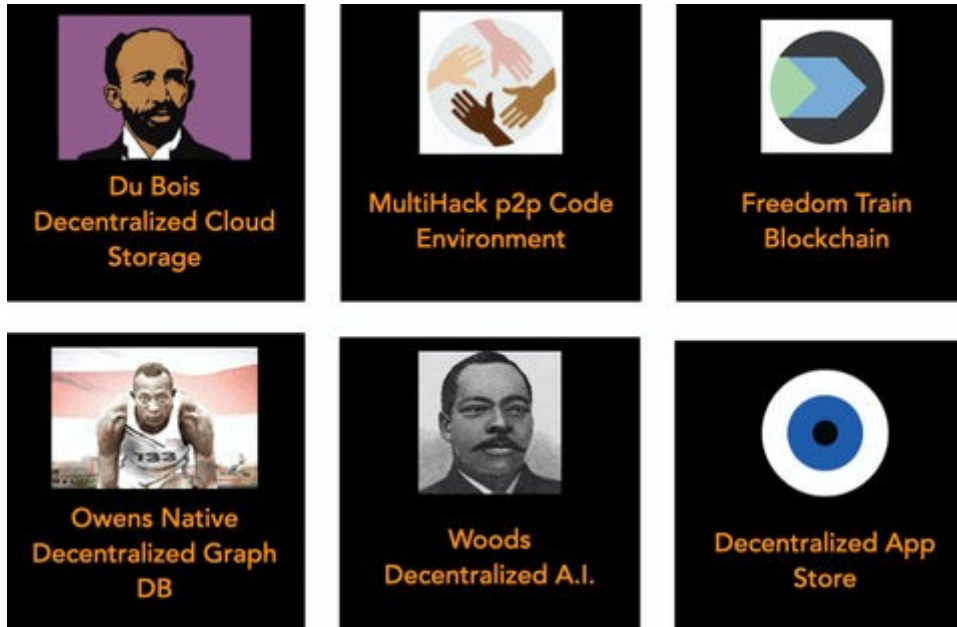

When companies use Douglass for cloud computing, cloud storage, or blockchain transactions, that activity happens across the whole network. Douglass redistribute this revenue to communities and individuals.

# **Timbuktu Acceptable Use Policy**

Timbuktu is a Community Market that is aligned with Beloved Community Pledge and the Beloved Community License. Timbuktu is a shared asset of the Douglass Community that is aligned with

Peace, Love and Purpose.

Timbuktu provides the tools and technology for merchants aligned with the Community products and service in the Timbuktu marketplace. While we believe the free and open exchange of ideas and products is a key tenet of commerce, there are some activities that are incompatible with Timbuktu and Douglass core mission and values.

This Acceptable Use Policy describes activities that are prohibited in connection with your use of the Services.

## The following activities are prohibited:

1. **Child exploitation:** You may not offer goods or services, or post or upload Materials that exploit or abuse children, including but not limited to images or depictions of child abuse or sexual abuse, or that present children in a sexual manner.
